The process of Centralized Valuation of Answer Scripts of SSLC (HI) & THSLC (HI) Examinations March 2020 will be commenced on 02.04.2020 at Pareekshabhavan. Eligible and qualified teachers of Special Schools can apply for Assistant Examinership in the prescribed application form through the Head of the Institution.

Eligibility for Examiner ship

1. Those who are handling classes to the particular subject during the Academic Year 2019-20
2. The teachers against whom disciplinary action is pending for any reason and who are found guilty of such misconduct are not eligible.

The Examiners will be paid remuneration as per existing orders. They will also be paid TA & DA as per G.O. (P) No. 85/2011/Fin dated: 26.02.2011. The duration of valuation will be from 9.30 AM to 4.30 PM. Each Examiner will have to value the following number of answer scripts per day.

Physics, Chemistry, Biology, History & Civics (SS1)
Geography & Economics (SS2)

} 36 Scripts

English, Malayalam, Mathematics

} 24 Scripts

The Examiners will have to make their own arrangement for boarding and lodging. However there is no objection in using the camp building allotted by camp officer for the purpose for their accommodation.

Specimen copy of the application is enclosed. Before countersigning the applications, the controlling officer (Head of Institution) should make sure that the applications have been duly filled up with the correct information by the applicant.
